The Ministry of Foreign Affairs and International Cooperation of the Co-operative Republic of Guyana presents its compliments to the Embassy of the Federative Republic of Brazil and has the honour to refer to the latter's Note No:31/2025, dated February 19, 2025 requesting information regarding the authority through which Brazilian operators can request the additional license to transport passengers and cargo to Guyana under the International Road Transport Agreement.

This Ministry has the further honour to advise that Brazilian operators desirous of obtaining the additional license must submit an application to the Ministry of Home Affairs IRTA focal point, Mr. Gavin Lewis through the email address research@moha.gov.gy along with the following documentation within 120 days of receiving the original permission from ANTT.

- A certified copy of the original permission from ANTT
- Name and legal address of the firm's local representative
- Tax compliance documents.
- Internationally valid third-party insurance,
- Road transport license and any other company registration documents,
- Details of the transport services intended to be provided routes, schedules, vehicle specifications, and types of goods to be transported.
- The public proxy instrument appointing a legal representative in Guyana with full powers to represent the firm in all legal and administrative acts.

All documents must be prepared in English and Portuguese.

Additionally, the relevant specimen forms are forwarded herewith for the attention of the relevant authorities.

- Customs Declaration forms for passengers
- Cargo Declaration Form
- List of prohibited and restricted items
- Guyana Drivers license specimen

The Ministry in this connection looks forward to receiving soon the information regarding the insurance companies in Brazil that may be willing to offer insurance policies to Guyanese operators.

The Ministry of Foreign Affairs and International Cooperation of the Co-operative Republic of Guyana avails itself of this opportunity to renew to the Embassy of the Federative Republic of Brazil the assurances of its highest consideration.


